**2. Cancellation Policy:** You may cancel your Club Sponsorship with no further obligation at any time.

**3. Privacy Policy:** Your e-mail address and those of the Members in your Club, will not be given or sold to any unrelated third parties, individuals or organizations. From time to time MHOC may send other information or special offers to you as a Sponsor via email.
